BORROWING DUE TO DELAY IN JUNE STATE SCHOOL AID PAYMENT RESOLUTION

Whereas, NJSA 18A:22-44.2 provides a board of education the ability to enter into short term loans with the bank of their choice, if needed, due to the delay in the June state school aid payment; and Whereas, both June State School Aid payments are delayed until July, the Salem City School District will be required to borrow funds totaling \$900,000 to meet general fund and preschool expenditures for June; and

Whereas, the Salem City School District will borrow the funds from Franklin Bank no earlier than June 21, 2021 at 3% interest; and

Whereas, the State of New Jersey will pay the Salem City School District in full the principal of the amount borrowed and interest of \$1,725.00 no later than July 12, 2021 and

Whereas, the Salem City School District will repay to the bank in full the principal of the amount borrowed and interest of \$1,725.00 no later than July 12, 2021 and

Therefore, be it resolved by the Board of Education of the Salem City School District, approval of the borrowing of funds totaling \$1,725.00 at 3% interest due to the delay in the June State School Aid payments.

- 5. Request Board approval to contract with sending districts (Elsinboro, Quinton, Mannington, & LAC) for the 2021-2022 SY.
- 6. Request Board approval for the following Autism Consultant to provide services to special education teachers regarding students who are diagnosed with Autism.
