#### **Upon the Recommendation of the Superintendent of Schools**

1. Board approved the service contract between the Foundation for Educational Administration and the Salem City School District for a professional development workshop to be presented on April 5, 2023. The topic of the workshop is Teacher Evaluations: Legal Requirements and Emerging Issues. The contract is in the amount of \$2,200.00.
2. Resolved, that the Salem City Board of Education authorized Herbert Schectman, Business Administrator, to accept additional funding on behalf of the District from New Jersey Schools Development Authority (SDA) in the amount of \$209,916. The objective of the review is to identify opportunities for improvement as it relates to the procurement process. The review determined that a Corrective Action Plan is not required.
